- Currently enrolled as a second-year law student in good standing at an ABA-accredited law school; and
- Top 33% of Law School Class; and
- First Generation Law Student (defined as a first person in your immediate family to receive postsecondary education); and
- Legally eligible to work in the United States.

In addition to submitting your application for a 2L summer associate position, in order to be considered for this Fellowship opportunity, you will need to upload the following materials electronically to complete your application for this fellowship program:

- Cover letter (please indicate your interest in the program and location)
- Resume
- Law School Transcript
- First Generation Law School Student Statement (500 words or less)

Applications for this fellowship program should be received no later than August 9, 2024. EEO/drug-free workplace/E-Verify participant/Female/Minority/Veteran/Disability.
